IN 2023, NACTO AND THE BETTER BIKE SHARE PARTNERSHIP LAUNCHED THE THIRD COHORT OF THE TRANSPORTATION JUSTICE FELLOWSHIP, WHICH OFFERS EIGHT FELLOWS AN EIGHT-MONTH CURRICULUM DESIGNED TO DEVELOP THEIR INDIVIDUAL AND INSTITUTIONAL CAPACITIES TO CREATE A MORE JUST AND EQUITABLE MOBILITY FIELD. NACTO FACILITATES SKILLS-BUILDING SESSIONS, ONE-ON-ONE COACHING, SPECIAL TRAINER VISITS AND STRUCTURED COLLABORATION, AND FELLOWS RECEIVE DEEP SUPPORT AS THEY WORK ON TANGIBLE WAYS TO IMPROVE MOBILITY FOR COMMUNITIES OF COLOR. BY CREATING COMMUNITY, FELLOWS WILL BE BETTER ABLE TO TACKLE SOME OF THE TOUGHEST TRANSPORTATION CHALLENGES FACING OUR COUNTRY TODAY.

NACTO HOSTS PEER NETWORKS ON A RANGE OF TOPICS, INCLUDING NATIONAL TRANSPORTATION POLICY, BIKEWAY DESIGN, BIKE SHARE AND MICROMOBILITY, EMERGING TECHNOLOGY, SAFETY, EQUITY, AND TRANSIT. NACTO DEDICATES SIGNIFICANT RESOURCES TO SUPPORTING, TRAINING, AND NURTURING THESE NETWORKS OF CITY STAFF WHETHER THROUGH IN-PERSON EVENTS OR VIRTUAL FORUMS. THIS YEAR, WE ADDED TWO NEW PEERS NETWORKS OUR I I J A CITY COORDINATORS PEER NETWORK TO ENSURE CITIES ARE WELL-PREPARED TO ACCESS AND USE FUNDING FROM THE INFRASTRUCTURE INVESTMENT AND JOBS ACT, AS WELL AS OUR AUTONOMOUS VEHICLE (AV) WORKING GROUP, CREATED AS AV COMPANIES DEPLOY THOUSANDS OF DRIVERLESS CARS ON CITY STREETS ACROSS THE COUNTRY.

THAT BASIC PRINCIPLE FORMED THE FOUNDATION OF NACTO'S OPERATIONALIZING EQUITY WEBINAR SERIES. EACH SESSION HOSTED TWO CITIES IN CONVERSATION AS THEY DISCUSS HOW TO MOVE FROM AN EQUITY FRAMEWORK TO ON-THE-GROUND IMPLEMENTATION. FROM DETAILED BREAKDOWNS OF RACIAL EQUITY FRAMEWORKS TO WALK-THROUGHS OF REAL-WORLD PROJECTS, THESE LEARNING SPACES PROVIDED TOOLS AND TANGIBLE PATHWAYS TO TURN VISION INTO REALITY.
